Fife College Students' Association (FCSA) Update

1 Introduction

This paper captures the work of the FCSA that does not fall under the remit of the College's Academic Quality Committee. This will focus more on our work on Welfare and Equality issues, and enhancing the students' engagement with the work and life of the College. Work which relates specifically to course activities is reported to the College's Academic Quality Committee and can be found on the <u>Gateway</u>.

2 The FCSA and Fife College Awards

The rescheduled FCSA and Fife College Awards night took place on Friday 9 October 2020 and was a mix of live and pre-recorded presentations. We presented 13 awards live on the night to the recipient's homes, alongside seven awards which were pre-recorded as the winners could not make the date or were large team awards. To add to the celebratory mood of the event we also sourced messages of congratulations from a range of individuals including College leaders, local MSPs and MPs, Jason Leitch and Team GB Paralympic Athlete Derek Rae.

The awards that were delivered were done in a COVID safe manner, and the live event was broadcast from the Carnegie Conference Centre, with full social distancing being observed.

Feedback from the event has been very positive, with viewers and participants noting it felt like being at an actual awards event.

Due to the pandemic and the resulting limitation on physical events the FCSA has focussed on delivering a diverse offering of digital engagement opportunities. To do this we have established the FCSA Digital Office on Microsoft Teams. This is a Team which all students and staff are free to join and interact with as they want.

We use the Digital Office to support both our representation and extra-curricular activities. The Class Reps have a dedicated channel for their campus, as do our Liberation Officers who have a channel which focusses on each of their remits.

Our societies also have their own channels within the Team which gives the members a space to interact with others who share similar interests. In total we have 1028 members in the Office, with 30 active channels.

From our regular contact with students we are finding that the lack of informal



support between students is something that is being missed. This would normally be naturally fostered through on-campus attendance and sharing social spaces, however this is not something that is immediately recognised as a need by students as they are largely in their own homes.

We will continue across the year to try and improve the online social aspect within the Digital Office so we can hopefully provide more support to students as they enter their second semester.

4 FCSA Events

All of the events were free for students and in total 397 students attended. Although this number understandably lower when compared to the traditional on-campus Freshers stall event, the length and quality of engagement with the students is much higher. We are looking at continuing digital delivery of Freshers events going forward.

FCSA Pet of the Year 2020

Our annual contest was held across October and November this year with a total of 78 Pets being submitted and 427 votes being registered. This contest is designed to increase our social media presence and engagement and although numbers were lower than in previous years we still added over 150 new followers across Facebook, YouTube, and Instagram during the time of the contest.

FCSA Phantasmagoria

The annual Halloween event was fully digital this year. To help us deliver the event we also auditioned students from the HND Acting and Performance course to provide voices for the Halloween characters. Two students were successful in getting the parts and both were paid £100 for their work. We also provide the recordings to the students who can now use these as part of their professional show reels. In total 217 students took part in the challenge via the Digital Office and iLearn, this is an increase from the 57 who entered last year.

FCSA Reverse Trick and Treat

To help students with young families celebrate Halloween we organised a day of reverse trick or treating for our students. Students were able to request a visit from 'Frankie-Stein' via a digital form and we were able to fulfil the 25 requests that we received. On Halloween, Jade and Craig visited students across Fife delivering small goodie bags to 63 children in total.



Winter Wonderland Extravaganza

This year we initiated a new event working with Students' Associations (SA) across the country. This was done in an effort to build more buzz in creating a national event as well as offering our support to other organisations which may not be able to facilitate and fund a large schedule of events. We are working with Abertay SA, Borders College SA, Edinburgh Napier SA, Glasgow Clyde College SA and Scotland's Rural College SA.

The event compromises eight separate competitions which students can enter to be in with the chance of winning £100. These are:

- The Great Winter Bake-Off
- The Ice-olation Olympics
- Creative Writing Contest
- Festive Beauty Comp
- Art-tic Attack
- Gamers Tournament
- Video Recreation
- Big Quiz Night

On each day the National Champion will win £100 which has been donated by the SAs. The Fife Champion will also win £20 for each event.

We have promoted the events to the curriculum based on their specific areas of interest as well as promotion across our usual channels.

FCSA Next Steps

Jade Burnett organised and delivered our annual Next Steps event in November. This event aims to help inform and support students in their choices for after their current year of study. This includes help with personal statements, employment opportunities and other career and study options. This year we also introduced our YouTube series 'Getting to Know...' where Jade has interviewed local organisations to help promote their services and how students can support and be supported by their services.

Coming up we have our Winter Wonderland event for students and the local community in Dunfermline on 12 December 2020 and will be attending the College's annual Get Ready for Christmas event.

5 FCSA Sports and Health Update

Delivery of sports clubs/ societies

Due to Covid restrictions we have been unable to deliver physical sports clubs this term but are hopeful that these can be reintroduced in the new year. Online content has been delivered for FCSA Be Active Week including online yoga videos and workouts that students can take part in from home. Some Societies have been able to meet online via Teams including our Dungeons and Dragons and eSports societies. We held an online Gamers Tournament which was scheduled in the FCSA Digital Office.

Scottish Student Sport (SSS)

Two Fife College students currently enrolled on the 2020/21 SSS Leadership Programme which aims to develop young people and provide a framework for them to enhance their leadership and employability skills. Kirsten was appointed as the



SSS Tayside and Fife Regional Chair and now sits on the SSS Development Committee.

Healthy Body Healthy Mind

Fife College has now achieved the Working Towards stage of SSS Healthy Body, Healthy Mind Awards and are close to achieving Bronze. We are the first institution in Scotland to achieve this award following the restructure of the programme. The FCSA is now offering guidance and support to other Colleges and Universities who are working towards this scheme.

Active Schools and Active Communities

We are currently working to strengthen our relationship with Active Schools in Fife to develop sport and physical activity opportunities for senior high school pupils and Fife College pupils.

The FCSA sponsored Active Schools Awards Night and their Young Ambassador of the Year Award. We will also be meeting with Active Schools Manager alongside James Shield to discuss provision at the new campus and how we can best support opportunities for current and potential new students.

The FCSA met with Active Community Sports Hub Officer to discuss Fife-based playing and volunteering opportunities for students across Fife. On the back of this, Jade created a 'Get to Know You' video for students to engage with as part of our Next Steps Event.

Cycling and Active Travel

We were awarded with a grant of £13,995 to purchase electric bikes and related equipment for Fife College. This project will deliver a pool of 8 ebikes to the College and can be trialled by staff and students for short term.

Hope Jensen has been appointed as the new FCSA Campus Cycling Officer. Hope, who graduated from Fife College in 2018, took up this position, which is fully funded by Cycling Scotland, in November 2020. Hope will help to coordinate the ebike project as well as sourcing other funding opportunities.

6 Thank You Form

To help with morale, the FCSA introduced a new Thank You form which our students can use to show their appreciation to the College staff for their efforts across the year. To date 148 notes have been registered since the form was launched on 21 October 2020. When we receive a note we send the thanks onto the staff member as well as their line manager. Students have appreciated having the opportunity to pass on their gratitude and staff have noted feeling very positive after receiving the notes of support.

We will continue to promote the form on a monthly basis going forward.



7 Other Updates

Think Positive Grant Scheme

Jade has secured a small grant from the Think Positive scheme which will go towards the development of a motivational planner to help students throughout their studies.

Stand Alone Pledge

The FCSA is working with Stand Alone and the University of Strathclyde to develop a pledge for Student Associations/Unions to represent the need of our estranged students.

CDN Awards

FCSA Manager Craig Walker has been shortlisted for the CDN College Colleague of the Year Award and the ceremony is taking place on Thursday 3 December. We want to congratulate Craig on his nomination and thank him for his continued hard work and guidance.

College Innovation Awards

The FCSA was delighted to win the Fife College Innovation Award for New Systems Process or Procedure for our submission on our work in integrating Teams and Forms to increase our efficiency and processes. This is the second time the FCSA has won this award, in 2018/19 our *Reppin' Player One* project was selected as the winner.

Update on Governance Matters

1 Introduction

This paper is to bring Board members up-to-date on Board membership and governance related issues.

2 Board Vacancies

Following on from the resignations of Tina Vandermotten and Amanda Kindness, our two Board vacancies will be advertised towards the end of January 2021 with a view to filling the positions by Easter. The Chair's Committee is due to meet to discuss the overall skills matrix, and members will be kept updated throughout the process.

3 Schedule of Board and Committee Meetings 2021-22

A draft schedule of Board and Committee meetings for 2021-22 is attached as Appendix 1. Members are invited to approve the draft schedule. Meeting invitations will thereafter be issued including a Teams link and a venue, with arrangements being confirmed closer to the date. Once on campus meetings resume, Teams will continue to be an alternative option for members where they are unable to attend in person for whatever reason.

4 External Effectiveness Review (EER)

Ron Hill facilitated a session with Board members on 27 November 2020 when the External Effectiveness Review Report was agreed as accurate and the recommendations made were discussed. A final version of the report is now available and can be found here. The report will now be submitted to the Scottish Funding Council and published on our website. An action plan will start to be drafted and further input from Board members will be requested in the New Year.

5 Updates to <u>Standing Orders</u> and <u>Scheme of Delegation</u>

These documents were last updated in December 2016 and December 2018 respectively. It is recommended that the documents be updated to reflect changes to job titles and reference to Executive Team (instead of Senior Management Team). Within the Standing Orders, the appointment of a Vice Chair was included but there is no reference to appointment of a Senior Independent Member, so an additional paragraph has been inserted. Documents can be find using the hyperlinks provided in this paragraph title should members wish to review these. Members are invited to approve these changes. It is also suggested that both documents get reviewed least every two years, in June so they can be effective from the start of the new academic year. The next review would be June 2022.

6 Briefing Sessions

As was agreed at the last meeting, an indicative schedule of briefing sessions to be held at the start of Committee meetings was issued by email following on from the last Board meeting. The first two briefings were held as part of the Health and Safety and HR Committee and the Academic Quality Committee meetings. Members are reminded that they can join any of the sessions that they are interested in, even if they are not a member of the Committee. A copy of the indicative schedule is available on Teams and on the <u>Gateway</u>, and reminders will be issued prior to each session. The schedule is indicative in case business priorities change and/or if presenters are not available.

7 Student President Elections 2021-22

Planning has started for the election for Student President elections. The elections have been planned for slightly later than previous year to maximise the opportunity for some on campus campaigning. Last year's campaigning was undertaken completely remotely, and this will remain as an option for this year too. Elections will be for the position of Student President Welfare and Equality, as the Student President Education and Reputation was filled for a 2 year period so will continue to be held by Sarah Ferguson for a further year. As in previous years, the Director: Governance and Compliance will act as Returning Officer, supported by the FCSA Manager acting as Depute Returning Officer. Some new ideas and improvements to the process are being explored by the FCSA Manager based on learning and feedback from last year's process.

8 TES

The subscription to TES has now been in place for one year. After seeking feedback from Board members, there was no appetite to continue with this subscription as online materials were not directly relevant to the Scottish FE sector. Members commented that the daily Monitoring Report issued by Colleges Scotland, via the Director: Governance and Compliance, was more relevant.

9 Governing a College Using Virtual Meetings

The above report was commissioned by CDN and AOC and will be published on Monday 7 December 2020. A link to it will be provided once available. Ron Hill was involved in the research and drafting the report. The research demonstrated that Colleges (in Scotland and England) overall had responded well to a quick change to virtual meetings and allowed governance arrangements to continue. Whilst virtual meetings have been useful during the Covid-19 pandemic period, they are not a substitute for face to face meetings. The report gives some recommendations on how to maximise the effectiveness online meetings, and suggests that a "blended" approach might be desirable longer term.

Summary of Committee Business

Health and Safety and HR Committee: 27 October 2020

- A briefing session was held on Transformational Changes to Ways of Working as a result of the introduction of the new HR information system.
- An update was given on the significant additional work that had been undertaken to
 ensure that appropriate safeguards were put in place to meet Scottish Government
 guidance on response to the Covid-19 pandemic to ensure the health and safety of
 students and staff. Committee members congratulated staff on the exemplary work
 undertaken.
- Statistics for 2019-20 were presented to the Committee and it was noted that there continues to be an aging staff base. This matter will be discussed again in more detail at the next meeting.
- Updates were given on National Bargaining. In particular it was noted that settlement had been reached with the EIS on the pay award. Negotiations were continuing with UNISON.

Academic Quality Committee: 28 October 2020

- A Board briefing session on Partnerships: Universities and Colleges was held. It was noted that the number of articulation routes in place had increased and that a range of university partners were used. For many learners, enrolling for an HNC/D at the College and articulating into year 3 of a University degree programme was a better option. The importance of having the right partners and of being able to have open and honest dialogue was key. It was hoped that the SFC Coherence Review would help Colleges address ongoing issues of parity of esteem.
- Karen Corbett had retired from Education Scotland and Janet Campbell had been appointed as the College's HMIe. Janet joined the meeting as an observer, and will also observe a future Board meeting. It was noted that Education Scotland and SFC had removed the requirement for colleges to submit an EREP in 2019-20 due to the Covid-19 pandemic.
- Student recruitment, student satisfaction and survey response rates were all noted as positive as Board members will see from the Business Report.
- SQA had advised that exams will not go ahead in 2019-20. Guidance is awaited. Fife
 will take a consistent approach. Fife College staff will be fully briefed once all
 requirements are known.

Audit and Risk Committee: 19 November 2020

- The annual pre-meeting with internal and external auditors and non executive Committee members took place with very positive feedback received about all aspects of the internal and audit processes for 2019-20.
- Strategic Risk Register changes were outlined and noted and it was highlighted that some risks continued to score net risks in excess of tolerance levels. This was due to the current volatile external environment which was outwith the College's control. Reassurances were given that the Executive Team members were regularly reviewing these risks and taking timely and appropriate action where possible.
- The Audit and Risk Annual Report to the Board was reviewed and approved, and is included on the Board agenda.

<u>Joint Audit and Risk Committee / Finance Commercial and Estates Committee:</u> <u>19 November 2020</u>

- Draft Fife College Annual Accounts 2019-20 were reviewed and it was agreed to recommend these for approval to the Board of Governors in December.
- The External Audit Annual Report was reviewed and accepted, and letter of representations approved for sign off on 9 December 2020.
- An annual update on grants made by the Arm's Length Foundation and confirmation of the remaining funds was received.

Finance Commercial and Estates Committee: 19 November 2020

- Digital and Estates updates were presented showing projects were proceeding according to plan.
- The draft Estates Strategy was presented with some further changes suggested and will be submitted to the Board for approval at the December 2020 meeting.
- The financial position for September / October 2020 was ahead of target and was being closely monitored by the Finance Services team. Plans were in place to accelerate or stop spend to accommodate fluctuations as a result of the volatile external environment.
- Academic Fees for 2021-22 were approved, and are unchanged from 2020-21 levels.
- The Procurement Annual Report was also approved.
