

#### Fife College Students' Association (FCSA) Update

#### 1 Introduction

This paper reports the work of the FCSA against our aims and commitments within the FCSA 2025 Strategic Plan and the work of the Student Presidents against their elected aims.

This work will be summarised into key messages and fuller detail of all work will be available for further information (deep dives) later in the document. Work which relates specifically to course activities is reported to the college's Academic Quality Committee. This paper is included within your packs.

## 2 President Updates

#### <u> Emma Wallace –</u>

## Ensure the students' learning experience is a top priority when regarding safely returning to in-person learning

Emma has been addressing all issues regarding the learning experience and making sure the right staff and contacts have been made. Emma has been speaking to students to ask how they are finding being back on campus and speaking to class reps during the meetings.

#### Improving the accessibility to facilities at Fife College to help students, especially those that can help students' mental health and wellbeing Emma has been involved in the new Health, Safety and Wellbeing committee to find student representatives to be involved in the Student Community group to find out

student representatives to be involved in the Student Community group to find out what should be improved regarding mental health facilities.

#### Introduce a 'Question Time with the Presidents', where the Presidents showcase their work to help students understand what they are doing to enhance the student experience, and give the opportunity for students to ask questions

Monthly updates have started to be published on social media so students can see what progress, tasks and events have taken place during the month. Updates have also been posted on the new FCSA monthly newsletter and discussions have started around having a segment on Boom radio for updates.

## Reduce the gap between College and University/Employment by creating opportunities for workshops and work experience

Emma has been in contact with Ann Playford around giving support for articulating University students and research about support in university has started. Contacts have also been made with Fife Voluntary Action and Student Employability hub around promotion of volunteering for students.

Introduce workshops to help students within the College, including essay writing, project planning and time management to help assist with learning Emma has been involved with the Digital Capabilities for Students group and has been promoting the Digital Familiarisation course created for students.

#### Natalie Fisher -

#### Introduce Workshops on BSL and Deaf Awareness

Due to unforeseeable circumstances the Deaf Awareness and BSL Taster Sessions have been postponed until further notice.



Tali has created her own Deaf Awareness interactive sessions and PowerPoints. Tali was approached by Linda Anderson (Lecturer) and asked to facilitate a Deaf awareness session to the BA childhood studies course, which was delivered on the 9th of March via teams.

Following the success of the first session, Tali will deliver this session again to a different group of students on the 14th of March. Anne-Marie O'Donnell (Lecturer) has asked Tali to deliver this session as part of the class's "Supporting children and young people who require additional support" unit. (more)

#### Campaigns to raise issues and awareness

The FCSA Mini Pride campaign took place on 23rd February. This was a collaboration with the FCSA LGBT Officers and was held in the Kirkcaldy and Glenrothes campuses. Students and staff were encouraged to wear rainbow colours, and the students could access promotional items, information, and leaflets as well as rainbow face painting. The event also featured representatives from NHS Fife and the Terence Higgins Trust. (more)

#### **Environmentalist President**

Tali continues to run the Green Club channel on Teams, posting blogs and other engaging content for students. (more)

#### Mental Health and Accessibility Support

Tali and Angela Grindle, the FCSA Student Engagement Coordinator, are currently collecting more feedback from students following on from the student mental health survey and will create a final report soon. This report will highlight student's current perceptions and awareness of the support that is on offer from Fife College. (more)

#### **Support for Housing and Financial Issues**

The 'Know Your Rights' campaign commences on Monday 25th of April and will run until Thursday 28th April. Citizens Advice and Rights Fife (CARF), and Fife Council will attend, as well as Aimee Dobie, Senior Education and Engagement Outreach Officer from the UK Government who will facilitate a workshop focusing on encouraging students to think about their rights and how to get involved with campaigning themselves. #### **Wellbeing Sessions**

Tali has secured a grant from NUS Think Positive which will be used to pay for a sixweek block of tai chi for students, this will tie into Wellbeing Wednesdays and part of the FCSA De-Stress Zones month, which will start in May and run until June. (more)

Work done in Q2/3 2021

- The FCSA and Fife College will host the Scottish Student Sport Conference and Awards night. This is the first time this event has been hosted by a college.
- The FCSA and Fife College have provided 50 free memberships to the Fife Sport and Leisure Trust gyms. (more)

- The team are currently working on a range of external funding opportunities to help increase our offer. (more)
- 4 Aim: By 2025, the FCSA will be recognised as a constructive force in all of its communities.

Work done Q2/3 in 2021

 All Presidents and FCSA Staff members are now involved with external volunteering. (more)



- The FCSA has become an official partner with the University of Strathclyde Student Union's Care Experienced and Estranged Students Network.
- In March we worked with Fife College to deliver a Health and Wellbeing festival which included a week of events for students.
- We worked with students from Creative Industries to create a video campaign for National No Smoking Day. (<u>You can view the video here</u>)

## Planned work

• In April our 'Know Your Rights' festival will connect our members with support organisations including Citizen's Advice, the UK Government, and Fife Council's Housing Team.

Work done in Q1 2021

• The review of the role of FCSA Online Engagement Coordinator has been completed.

• The team have completed a review of current processes to identify where time can be better used to help us adapt to the return to in-person delivery. Planned work

Planned work

- We are reviewing the expectations on FCSA Presidents including their capacity to deliver election pledges alongside mandated work, such as supporting the Class Rep system and student engagement with College quality processes.
- A new approach to engaging Apprentice's in the quality processes of Fife College is being developed and will be piloted in the Rosyth campus soon.
- 6 Aim: New Campus We will work closely with Fife College and our membership to deliver an FCSA presence which caters for the needs of our members as well as providing a platform for future development and success. Work done in Q1 2021
  - The FCSA have helped to facilitate three projects with the University of Edinburgh's Shared Learning Spaces team looking at Common Areas, STEM Spaces, and Public Art.
  - The FCSA are involved with the design of the Sports and Fitness areas of the new campus.

## Planned work

• The FCSA are going to gather more student feedback on what sort of space would suit the students and the FCSA in the new campus.

# 7 Aim: Overseen by a Trustee Board, the FCSA will move towards being fully autonomous

### Work done in Q2/3 2021

- Recruitment of members has begun with our 'Do you want to be an Oversight Group OG?' campaign, and four potential members have been identified. (more)
- Initial contact with the interested parties has been made by Craig Walker with an introductory meeting scheduled for April 2022.
- Evelyn McPhail has agreed to join the group as a member.

 After the introductory meeting the new members will be invited to attend day 1 of the FCSA Strategy Event on the 27<sup>th</sup> of June 2022.

#### Learner Engagement and Participation

Nominations for the FCSA and Fife College Awards will open soon. As part of the event we are working with the College's Prison team to collect creative works from our prison-based members which can be showcased on the night.

#### Health

Tali Fisher, Emma Wallace, Lauren Rosenbaum and Angela Grindle recently joined Fife College Staff members in completing their training in Scottish Mental Health First Aid. All paid members of the FCSA now hold this certificate. The sessions were delivered by John Blakey who completed the train the trainer programme through funding given by the FCSA in 2015/2016.

The FCSA worked alongside the College's Health and Well-Being Team to host the Well-Being festival for students, with 442 students attending on campus. (more)

#### **Development**

The FCSA secured external funding from Paths for All, matched by Fife College, to employ a Sustainable Travel Officer who will work to promote healthier and environmentally sustainable methods of travel. Recruitment for this post is underway.

The FCSA website, <u>www.fc-sa.net</u>, has begun to grow its audience following its soft launch. (more)

#### 9 Other Notable Items

The FCSA's 'Get On Our eBikes' eBike hire scheme has proved very popular with students and staff, with the whole fleet of ebikes being regularly hired out. So far £275 has been raised through hires, which cost students and staff £2.50 per week. The funds that we have raised from this scheme will be donated to the Disasters Emergency Committee's Ukraine Humanitarian Appeal.

#### Update on Membership and Governance Related Matters

#### 1 Introduction

This paper is to bring Board members up-to-date on Board membership and governance related matters since the last meeting.

#### 2 Board Membership

Since the last Board meeting, Scottish Ministers have approve the appointment of Phillip Thompson as a Board member. He will also remain a member of the Finance, Commercial and Estates Committee.

Susan Mitchell's term of office is due to end on 31July 2022. The Chair's Committee at its meeting on 9 March 2022 recommended that Ministerial approval be sought to re-appoint Susan as a Board member for the period 1 August 2022 to 31 July 2026.

On 31 July 2022, Shona Cochrane and Jim Trail OBE will have served their maximum term of office and will step down from the Board. We are extremely grateful to Shona and Jim for their valuable contributions over so many years and will find an appropriate way to mark their departure. The Chair's Committee reviewed the skills matrix and agreed to take steps to arrange for the two forthcoming vacancies to be advertised and interviews held.

Shona Cochrane is Chair of Academic Quality Committee and Jim Trail is Chair of Finance, Commercial and Estates Committee. The Chair's Committee recommend the appointment of Zoe Thomson as Chair of Academic Quality Committee with effect from 1 August 2022, which will also mean Zoe becomes a member of Chair's Committee. It was also recommended that Susan Mitchell (currently Chair of Audit and Risk Committee) transfers to the role of Chair of Finance, Commercial and Estates Committee, and that Brian Fisher assumes the role of Chair of Audit and Risk Committee and becomes a Chair's Committee member with effect from 1 August 2022.

The Chair's Committee discussed options for Chair of Finance, Commercial and Estates Committee and members will be asked to approve an appointment to the position of Chair once a recommendation is available.

As members will be aware from previous Fife College Students' Association (FCSA) update reports, an FCSA Advisory Board is to be established. Initially a small number of members will be recruited, with a view to extending this as the remit of the Board becomes more established. In order to ensure that good relationships are maintained with the Fife College Board of Governors, a request was made for a Board member to be one of the first Advisory Board members. Evelyn McPhail has agreed to undertake this role, initially for a one year period.

#### 3 Amendment to Chair's Committee Remit

At its meeting on 9 March 2022, the Chair's Committee recommended that its remit be changed – please see amendment proposed in Appendix 1.

#### 4 Amendment to Governance Document: Dunfermline New Learning Campus

The New Build Project Board requested that the governance document previously approved be updated to reflect changes within the College and Project Team structure.

The document included as Appendix 2 was discussed at the New Build Project Board meeting on 16 March 2022 and is recommended to the Board of Governors for approval.

#### 1 Introduction

This paper provides a note of the Chair's updates for members since the last meeting.

#### 2 Updates

- Normal fortnightly meetings with Principal and Director of Governance and Compliance, as well as intermittent calls.
- Attended the College Development Network (CDN) National Awards Ceremony in Glasgow two awards for College, plus several honourable mentions.
- Attended virtually CDN courses on Prevent work and Funding sources with others to come.
- Met with Andrea Nolan Principal of Edinburgh Napier University.
- Met remotely with Frank Hughes of Lincoln College International in Saudi Arabia to discuss international work.
- Attended Chair's Committee and New Build Project Board meetings.
- Met twice with Vice-Chair and Senior Independent Director.
- Met with Jim Metcalfe CEO of CDN to brief him re our Strategy Day in May.
- Involved in many meetings of the Employers Association (EA) both with Unions, but also in restructure of EA.
- Heavily involved with Colleges Scotland Strategic Completion Group in developing a draft to go to members after Easter. (Lots and lots of meetings!!)
- Met twice with Minister Jamie Hepburn MSP to discuss Tertiary education in general and FE funding in particular.

## **BOARD OF GOVERNORS OF FIFE COLLEGE**

#### **Summary of Committee Business**

#### Academic Quality Committee: 16 February 2022

- A briefing session on Digital Portfolio Update: College Offer and Key Partnerships was held, presented by Stewart McDonald. A copy of the slides are available on <u>Microsoft</u> <u>Teams</u>. This demonstrated an innovative approached, linked in to industry and competitors, to ensure a modern curriculum which would meet needs of employers and students.
- An update was given on student enrolments and withdrawals, and the update the pandemic was having on this. An update on statistics will be provided at the Board meeting as part of the Business Report. An update will also be given on Learner Survey 1 which once again showed a better response rate than in previous years.
- Excellent progress continued to be made by the Fife College Students' Association (FCSA). It was agreed that the Committee would receive more detailed information on class representatives, including areas not represented, general balance, opportunities and challenges for discussion at the next meeting.
- An update on the recent Education Scotland Visit showed good progress with 43 positive progress notes made and 7 points suggesting further progress. The full report is available on <u>Microsoft Teams</u> and the Committee will monitor progress towards achieving the action plan that has been drafted to take forward to the further progress noted.

#### People and Culture Committee: 22 February 2022

- Local Trade Union representatives were invited to attend to discuss how working relationships were between TUs and management. It was confirmed that dialogue was open and constructive, and partnership working was seen as key moving forward
- An update was given on Health and Safety. There were no RIDDOR reportable incidents during the period. There was a discussion about the number of staff and students testing positive for Covid, and the changes to social distancing arrangements. An internal audit on health and safety had identified one action in relation to staff training. Training had commenced and a plan was in place to roll this out.
- Significant progress was reported with regard to Delivering the Human Resource Strategy and Workforce Plan 2018-23. Work had focused on agile / hybrid working, health and wellbeing, workforce planning and transformation of the OD and HR function

#### Audit and Risk Committee: 3 March 2022

- The <u>Strategic Risk Register</u> was discussed, with the impact of the current external environment being highlighted, with a helpful discussion on the New Learning Campus and on the Scottish Government's draft budget, which will be raised at the next Board of Governors meeting.
- It was noted that the external auditors had been appointed by Audit Scotland for a further year and it was agreed that the internal auditors would be appointed for a further year. As this will be the end of the contract for internal auditors, a timeline for the tender process to secure new internal auditors will be presented to the Committee at the start of next academic year.
- The assurance framework was presented to members with no concerns being identified.
- Good progress continues to be made by management in implementing internal audit recommendations.
- The Committee agreed that the <u>Planning for skills | Audit Scotland (audit-scotland.gov.uk)</u> report should be made available to all Board members.
- It was noted that sessions offered as part of the <u>Wellbeing Festival</u> were open to Board members. The next Wellbeing Festival is scheduled for 30 May – 17 June.

## Finance, Commercial and Estates Committee: 8 March 2022

- There was a briefing session on Commercial Activity and Business Engagement at the start of the meeting. A copy of the presentation is available on <u>Microsoft Teams</u>. Iain Hawker, Miles Lagan and John Elliot outlined the current position and priorities moving forward with regard to commercial activity and how we engage with employers and businesses.
- The Committee reviewed progress towards Digital and Estates objectives with good progress being made overall. Members were advised of pricing issues the contractor had with regard to the Dunfermline Learning Centre. Board members will receive an update on this at the next Board meeting.
- The financial position was £33k ahead of the year to date F1 position, and commercial activity was noted as being on track with several bookings in the pipeline. Members were pleased to hear that employers were starting to prioritise staff development again.
- An update was given on the draft budget issued by the Scottish Government. An update will be provided on this at the next Board meeting.

#### Chairs Committee: 9 March 2022

- There was a discussion about the forthcoming Board vacancies and it was agreed to proceed to advertise these. Options for filling discussed and recommendations will be made to the Board of Governors.
- A change was recommended to the remit of the Committee and will be submitted to the Board for approval.
- Members were updated on recent changes to remits of Executive Team members and the impact of these. It was noted that arrangements were working well.
